List of Products to be Sold:

The 2020 Farmers Market is located in Harmony Park – behind Harmony Crossing Shopping Center at the intersection of Highway 44 and Harmony Road in Eatonton, GA. The Farmers Market began on Saturday, May 23, 2020 (delayed 3 weeks due to Covid-19) and will end on Saturday, September 26, 2020 for a total of 19 (nineteen) markets for the season. The market opens each Saturday at 8AM and close at 12PM. Each vendor must have a 10' x10' tent/canopy to be placed over the table(s) where your product is displayed. Each Vendor is limited to 2 12' spaces/tents (unless grandfathered in).

The two fee options for exhibiting are: (1) a season pass for \$130 for the season which includes all markets OR (2) a "Pay-by-Market" option of \$15 for each Saturday you participate. If you choose the season pass option, it must be processed 2 weeks in advance of your first market so that your application can be processed, and a space assigned. You may pay by credit card or check for the season pass. If paying by check, please make it payable to Harmony Crossing, LLC and send to our accountant, Barbara Sherman at 112 Harmony Crossing, Ste 4, Eatonton, GA 31024. If paying by credit card, please contact Barbara Sherman at 478-457-4327 or via email at bsherman@vharmonycrossing.com. Anyone reserving a space for the entire season cannot miss over 3 consecutive weeks without forfeiting their reserved space. Anyone not participating on a given Saturday (both Season Pass and Pay-by-Market vendors) must let the Market Manager know via email or text by Wednesday of the week prior to the Saturday Market. The \$15 per market fee is paid when you arrive at the market; please provide exact change and place in an envelope with your name on the envelope.

All vendors must sell home-made/homegrown products and cannot operate a retail store. It is understood that anyone who reserves a space will not exhibit at any other market within 25 miles unless that market operates on a day other than Saturday.

I agree to follow all rules and regulations of the market and as required by law.
